All items must be juried by *Twin City Artisans (TCA)*. **No** food sales. **No** resale items. If you bring non-juried or resale items, you will be asked to remove them from your displays. No licensed items.

TCA Members are given entry precedence over non-members.

Vendor is responsible for setup from 2 to 6 pm. Teardown is immediately following the show. **Absolutely no early teardowns.** Fees are non-refundable. *Additional space may be available for an additional cost.*

You will be responsible for all sales transactions and sales tax.

Vendors may elect to use an 8 foot table provided by the Masonic Center or bring the size or display items you wish. Be sure to check your table choice. On occasion TCA will have additional space available. If this occurs you will be notified. **Vendors must provide table covers (falling to the ground).** Electricity is available on a first come, first served basis.

The Masonic Center and TCA are not responsible for any loss or damage to vendor property or merchandise.

Vendors must park in designated parking space.

Advertising for this show will include flyers posted in various area businesses, flyers distributed at shows by vendors preceding this event, email distribution of the flyer to customers, local free sources, as well as paid advertising in local print media and radio.
