All items must be juried by Twin City Artisans (**TCA**). **No** resale items. If you bring non-juried or resale items, you will be asked to remove them from your displays.

Nothing can be hung on walls and all displays resting on wall must have padding against the wall.

Vendor is responsible for setup. Teardown will be immediately after the event.

Absolutely no early teardowns.

TCA will ***NOT*** provide Central Checkout. You will be responsible for all sales transactions and sales tax.

We will try to accommodate your request for

- 5' round table (provided by PJCBG),
- 6'x6' display area around the perimeter You must provide your own display/tables. All of your display must fit within your area.
- Tables cannot be no larger than 6'. **Vendors must provide table covers (falling to the ground)**. Electricity is available. You must provide extension cord and be prepared to cover cord if necessary.

Please be aware the 6 x 6 booth areas are limited. If additional space becomes available, you will be notified.

TCA and **PJCBG** are not responsible for any loss or damage to vendor property or merchandise.
